


fiscal year 2001 report:

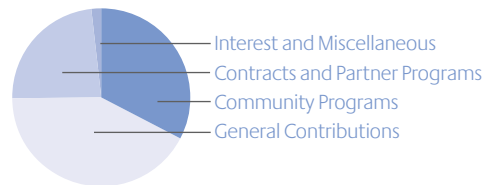
